School of Navigation and Sail Training

The Navigation School can report another very successful year. Our numbers for the three theory classes, which ran from October 2013 to March 2014, were slightly down on the previous year, with 7 students on the Day Skipper course, 9 students on the Yacht Master course and 5 students on the Ocean Master course, but we are pleased to report a 100% pass rate on all courses.

Our 'End-of-Term' Presentation Evening and Buffet took place at the end of March when, certificates and special awards were presented. The winners of the special Trophies were as follows: The Navigation School Trophy for the most improved Day Skipper was awarded to James Mair, the Roy & Mary Trophy for the best Day Skipper went to Keith Stone, the Noel Smythe Trophy for the most improved Yacht Master was won by Evan Ingram, the Quartermain Trophy for the Best Yacht Master was awarded to Mark Stedman and the Denys Tweddell Cup for the Best Ocean Master was won by John Adkin. The 'Muscateer' Tankard, the Principal's Special Trophy, was this year awarded to our 'Classroom Assistant', Michelle Stoneley, for her services to the Navigation School and to the Academy and the Mini Academy. In addition to our Navigation Theory courses, we also ran a First Aid Course in March, which was attended by 12 students and two VHF/SRC Courses, one in March, which was attended by 4 students, and one in November with 9 students.

During the summer months we continued to offer Competent Crew, Day Skipper and Coastal Skipper Practical Courses either aboard 'Torbellin', a 'Sigma 38', that is fully coded and is the dedicated teaching yacht for the RTYC Navigation School, but which we charter from 'Heron Sailing' or aboard members' own boats. In June 2 Students took the Yacht Master Offshore course, followed by an RYA Exam afloat and both were successful. Also in June we had our Mini Academy students from Chilton Junior School when six 11 year olds had a 6-week Module in Navigation which included 4 sessions afloat as an 'Introduction to Sailing' and in September 2 students took their Competent Crew Course, which included a trip to Boulogne. Members were also able to complete the 'ICC' course - International Certificate of Competence, which is required for sailing in European waters, and the CEVNI Course - the Inland Waterways Certificate which is required for the French, Belgian and Dutch canals and inland waterways.

With our 2014/15 theory season now under way, we are all looking forward to yet another successful year. This coming year, our numbers are back up to our expected average with a total of 29 students, 13 enrolling on the Day Skipper course, 10 are studying for the Yacht Master Offshore and we have 6 students on the Ocean Master course.

None of this would happen without the dedication of our instructors, to whom I give my sincere thanks. The Day Skipper course this year is being run by Mike Greenstreet with the assistance of Roy Fomison, Nigel Collingwood and Chris Cox. Michelle Stoneley is assisting me in the Yacht Master course and congratulations to Andrew Beaumont-Hope who, earlier this year, qualified as an RYA Shore-Based Instructor and has joined me as an 'Ocean' Course Tutor. We also have to thank Elizabeth Anderson, our Administration Officer, who has again done a superb job in looking after the enrolment of our students, ordering all our student packs and keeping a firm hand on our purse strings.

In addition to the teaching services we offer to members of our Club, a further aim of the Navigation School is to make annual donations to the Royal Temple Yacht Club, and I am pleased to announce that the Navigation School's finances are in a very healthy state. So far this year we have bought a Defibrillator for the Club at a cost of £845.00 and we are now looking forward to funding new projects, small or large, as and when requested by the General Committee.

Another year in the position of House Officer, has again flown by. We have a beautiful clubhouse however, the upkeep is a never ending project.

We have had a very busy year, and I must say "thank you" again to Carol, Barry and Sue as a team, for their help and support throughout the year. Managing the day to day tasks required in the clubhouse, the daily cleaning duties, and dealing with minor repairs and, many smaller "in house" jobs. Clive Nichols, our previous Bosun, has come in on a part time basis, attending to some of the general maintenance requirements that have arisen, thus getting things done on time and representing a considerable saving to the club without the need to use outside contractors.

The highlight of the year was in May, with the royal visit to RTYC by His Royal Highness the Duke of Kent. To show the clubhouse at its very best, there were weeks of preparation including decorating, cleaning, polishing and making sure everything had been perfectly prepared for the visit. The result of all the hard work, being the Club looked terrific. A great team effort!

The main project for this year, has been to completely refurbish and upgrade the club kitchen, All works were carried out by contractors JJ UK, completed on time, with minimum disturbance to the general workings of the club, and within the allocated budget. This all went ahead without any unforeseen problems and we are now seeing the benefits of this investment in the form of the improved service and reliability. A storage cupboard for the catering equipment has also been built on the landing to prevent the use of the Snooker room as storage.

During the year, the usual tasks have been carried out, such as the carpets cleaned regularly, the annual check to the roof and guttering, safety testing of the electrical equipment, The regular cleaning of the silverware in the trophy cabinet, and various white goods have been purchased including an extra microwave and washing machine.

The modernization of the bedrooms is still ongoing, with the purchase of new items of furniture, the sponsored Brass Name plates for the bedroom doors are now in place, and Bedroom 7 the family room, is due to be online soon. The Public Address/Music system has been upgraded, allowing us to use this throughout the clubhouse and also outside on the terrace, especially during functions such as Ramsgate Week. The reorganization of the store rooms in the hold bar has allowed for more efficient use of the space, and the CCTV has also been extended again with the installation of a new up to date monitor adding to the club security. There have been repairs to the Terrace, and the handrail to the lower steps, and the purchase of new Terrace furniture and sun umbrella.

The never ending tasks of repair and redecoration of the building continues with our ongoing improvement programme I can report that the upgrade and redecoration of the Gents and Ladies cloakrooms will be scheduled for early in the New Year. RTYC Academy

In February this year the Commodore, Dave Parish and Dick Smith again took our Power Point Presentation out to Dane Court School, St.George's school and The Marlowe Academy to recruit 'The Class of '14'. Twenty students from these three schools signed up for our six theory sessions on Wednesday afternoons in March, with instruction given by members of the Navigation School and Academy Committee. Attendance and enthusiasm was high and on May 27th all 20 students attended an award ceremony held at the Club, where they were presented with their Certificates of Basic Navigation (shore Based) by HRH Duke of Kent.

Throughout May and June the 20 students from the Class of '14 joined the 8 students who had re-joined from the previous year and were allocated to one of our racing boats each Sunday to put into practice the skills they had learnt in the classroom. By the end of the Spring Series, 6 students had failed to take up the opportunity to go out on the water and, although very keen, 8 more had to return to Norway at the beginning of July. The remaining 14 students continued to sail throughout the season, taking part in Ramsgate Week and the Autumn Series, with 12 being signed up as permanent crew on one of our racing boats.

At the annual Club Prize Giving, Commendation Awards were presented to Olivia Britton (X-Waves) and Courtney O'Toole (Principessa) for their achievements in sailing during the season. The Junior Cup was awarded to Mitchell Stokes-Carter who has now completed his second year as 'Foredeck' aboard Principessa.

In July the Navigation School also provided a 10 week Navigation Module for a small group of 11 year old students from the Chilton Junior School which formed part of their Year 6 'Sports Syllabus'. The 'Mini Academy' course included some classroom tuition as well as practical sessions afloat. Two of our 'Class of '14' Academy members have offered to join our 'schools visiting team' to talk to their peers about their own experiences this year and an invitation will be extended to them to join our Academy Committee. The Theory Course, again run by the Navigation School with the assistance of members of the Academy Committee, will take place, in the New Year, after our School visits.

We are delighted to see Academy members using the Club and joining in Club activities ashore as well as afloat. For this success, thanks must go to our Boat Owners/Skippers who are willing to take these young novices to sea in Club races and mould them into useful crew members and we look forward to seeing this new section of the Club grow during the coming years.

Finally, Breaking News – Toby Wood, who is currently studying for his Yacht Master Ocean (Shore-Based) Certificate with the Navigation School and who has recently finished his third season crewing aboard X-Waves, has just heard that he has been accepted into the UKSA British Keel Boat Squad. Well Done Toby.
